- Dec.** Established Minemachi Factory in Ota-ku, Tokyo, and began machinery installation and piping work.
- Jun. 1952** Changed company name to Ebara Jitsugyo Co., Ltd.
- Oct. 1985** Split off the Minemachi Factory and established Ebajitsu Co., Ltd.
- Nov. 1998** Registered with the Japan Securities Dealers Association for over-the-counter trading.
- Feb. 2001** Listed on the Second Section of the Tokyo Stock Exchange.
- Mar. 2004** Listed on the First Section of the Tokyo Stock Exchange.
- Mar. 2016** Shifted to a company with Audit & Supervisory Committee.
- Apr. 2022** Transitioned to the Prime Market due to the reorganization of market segments on the Tokyo Stock Exchange.

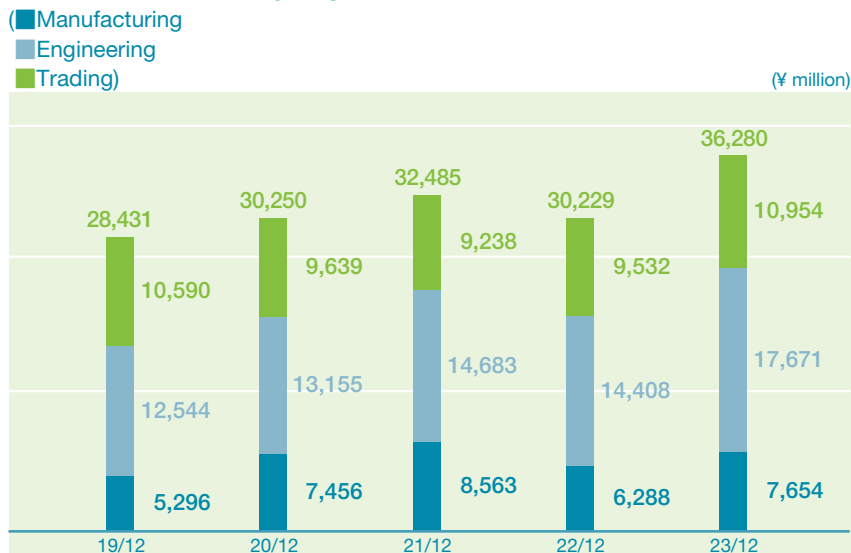

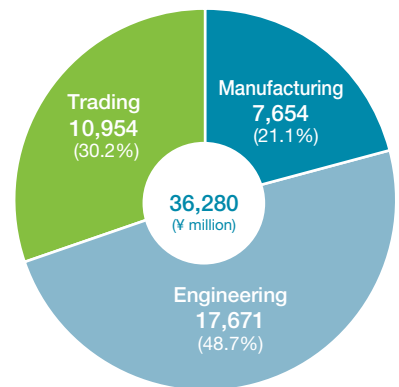

Historical sales Data by Segment



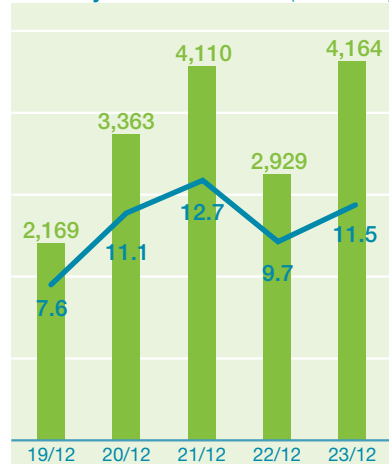
Percentage of sales (FY2023)



Operating income (■) Operating income ratio (—) (¥ million/%)



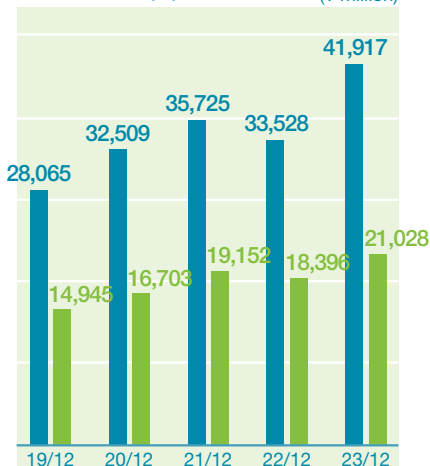
Ordinary income (■) Ordinary income ratio (—) (¥ million/%)



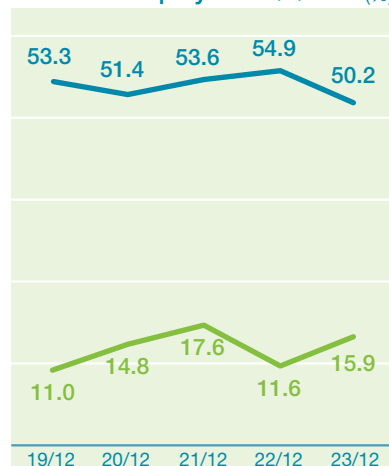
Net income attributable to owners of parent (■) Net income attributable to owners of parent ratio (—) (¥ million/%)



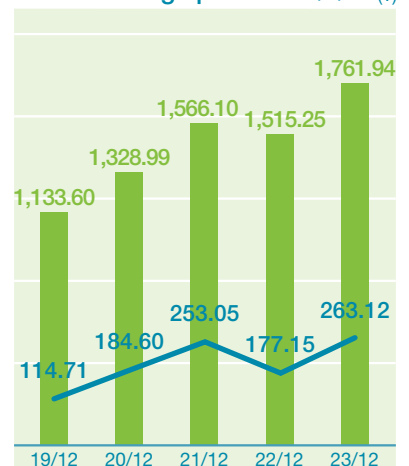
Total assets (■) Net assets (■) (¥ million)
